paid by William Wheeler Esqr of State and district aforesaid have Granted  
Bargained Sold and Released and by these presents do Bargain Sell and  
Release unto the Said William Wheeler Esqr all that parcell or tract  
of Land lying on the West Side of Reedy River Supposed to be by compu-  
tation thirty five acres be the same more or less Beginning on a branch  
below the School House Spring where Reuben Martins line crosses thence  
down said Branch to the lower corner of an old field to a conditional  
Maple corner made between said Gibson and William Thruston thence  
a north westerly direction a conditional line to a post oak corner above  
the old Field near the top of the Ridge thence West of north on open line  
to a maple on John W Hancocks line thence with said Hancocks line to Reuben  
Martins line thence with said Martins line to the Beginning Together with  
all and Singular the Rights members Hereditaments and appertaining  
thereunto belonging in any wise appertaining to have and to hold all  
and Singular the Said premises unto the Said William Wheeler Esqr  
his heirs or assigns forever and I do hereby bind myself my heirs  
Executors or Administrators to warrant and forever defend all and  
singular the aforesaid premises unto the Said William Wheeler Esqr  
his heirs against myself my heirs Executors administrators and assigns  
forever in Testimony Whereof I have hereunto set my hand this 26<sup>th</sup> day  
of June one thousand Eight hundred and thirty one

This Indenture made this the Twenty first day of January 1832  
Between William Russel of the State of Genesee and County of Cork of  
the first part and Daniel Pace of the State of South Carolina and district  
of Greenville of the other part witnesseth that for and in consideration  
of Twenty five dollars in hand paid to the Said William Russel the Rec-  
eipt and payment of which is hereby acknowledged hath granted  
and Bargained Sold Conveyed and Confirmed and by these presents  
doth Give Grant Bargain and Sell Convey and Confirm unto the Said  
Daniel Pace a certain tract or Parcell of Land lying and being in  
the State South Carolina and District of Greenville on the Waters of  
Fall Creek Joining land Belonging to Eleckander McKenney on the  
South Side and Thomas Morgan And Squire Morgan on the north side  
containing Two hundred acres be the same more or less which Land was  
Granted to William Russel in 1814 begining at a poplar thence south
