Eleventh of June in the year of our Lord one thousand Eight hundred and twenty eight at the Suit of Jeremiah Cleveland to me directed Com-manding me that of the Goods and Chattels Lands and Tenements of Reubin Harrison to Levy the Sum of Four hundred and fifty four dollars and Eighty Six cents Damages and Costs I have Seized and taken of the Lands and Tenements of the Said Reubin Harrison all that certain piece parcel and tract of Land containing fifty acres more or less Situate and being in the district of Greenville lying on the north East Side of the tract of Land whereon the Said Harrison now lives Beginning on a stake 3x thence S 12 W 45 chains 50 links to a stake 3x thence N 79 W 46 chains thence E 25 to the Beginning this being part of a tract of 189 acres originally Granted to Genl John Blasingame Deceased and whereas the Said premises with their appertinances since the Seizure by me made by virtue of the Said writ of Fieri Facias before mentioned have been Exposed to Sale at public Vendue and purchased by Jeremiah Cleveland of the district aforesaid for the Sum of Twenty dollars being the highest Sum that was bidden therefore Now Know ye that I William Blasingame Sheriff aforesaid by virtue of the Said writ of Fieri Facias aforesaid to me directed and delivered as aforesaid and by virtue of the Statute in such Cases made and provided and for and in consideration of the Said Sum of Twenty dollars to me in hand paid or Secured to be paid by the Said Jeremiah Cleveland the Receipt and payment whereof I do hereby acknow-ledge have Granted Bargained and sold and by these presents do Grant Bargain and sell unto the Said Jeremiah Cleveland his heirs and assigns forever the Said tract piece and parcel of Land with its appertinances and all the Estate right title and Interest which the Said Reubin Harrison of right had of in and to the Same to have and to hold the Said piece parcel and tract of Land with its appertain-ances unto the Said Jeremiah Cleveland his heirs and assigns forever as fully and absolutely as I the Said William Blasingame might could or ought to Grant Bargain and sell the Same by virtue of the Statute aforesaid and the Said writ of Fieri Facias or otherwise In Witness whereof I the Said William Blasingame have hereunto set my hand and seal the Sixth day of June in the year of our Lord one thousand Eight hundred and Thirty Two
