

To all to whom these presents shall come I William Blasingame Sheriff of Greenville district and State aforesaid send Greeting Whereas by virtue of sundry writs of Fieri Facias Issued out of the Court of Common Pleas held for the district of Greenville tuted the Eleventh day of June in the year of our Lord one thousand eight hundred and twenty eight at the Suit of Jeremiah Cleveland to me directed commanding me that of the Goods and Chattles Lands and Tenements of Reubin Harrison to Levy the Sum of four hundred and fifty four dollars and $\frac{86}{100}$ Damages and Costs I have seized and taken of the Lands and Tenements of the Said Reubin Harrison all that certain piece parcel and tract of Land containing Three hundred acres more or less Situate and being in the district of Greenville on the North Side of Salludia River Beginning on a crab apple tree on the Bank of the River Running thence N^o 71 E 13 chains to a red oak 3x thence N^o 19 W 52 chains to a stake 3x thence W 37 chains to the River thence down the meanders of the River to the Beginning and where as the Said premises with their appertainances since the Seizure by me made by virtue of the Said writ of Fieri Facias before mentioned have been Exposed to Sale at public Vendue and purchased by Jeremiah Cleveland of the district aforesaid for the Sum of one hundred and Seventy five dollars being the highest Sum that was Bidden therefor now know ye that I William Blasingame Sheriff aforesaid by virtue of the Said writ of Fieri Facias aforesaid to me directed and delivered as aforesaid and by virtue of the Statute in such case made and provided and for and Inconsideration of the Said sum of one hundred and Seventy five dollars to me in hand paid or secured to be paid by the Said Jeremiah Cleveland the Receipt and payment whereof I do hereby acknowledge have Granted Bargained and Sold and by these presents do Grant Bargain and Sell unto the said Jeremiah Cleveland his heirs and assigns forever the Said tract piece and parcel of Land with its appurtenances and all the Estate right title and Interest which the said Reubin Harrison of right had of in and to the Same To have and to hold the Said piece parcel and tract of Land with its appurtenances unto the said Jeremiah Cleveland his heirs and assigns forever as fully and absolutely as I the said William Blasingame might could or ought to Grant Bargain and sell the Same by virtue of the Statute aforesaid and the Said writ of Fieri Facias or otherwise in Witness whereof I the said William Blasingame have hereunto set my hand and seal the sixth day of June in the year of our Lord one thousand eight hundred and thirty two Signed Sealed & delivered by William M Goodlett
