 these presents do Grant Bargain Sell and Release unto the said Wm Cochrum
 a plantation or parcel of Land lying and being in the district and County
 aforesaid it lying and being in the County of Greenville on the Waters of South
 Carolina River thath such Shapes and forms and marks as appears by the
 plat to the said Grant annex the said plat and Grant being duly Recorded
 in the Secretarys office for William Clayton Beginning on John McBlues
 line Running No west to Gentrys line from thence No wt along Gentrys line to an
 agreed line Between the Gentry and Clayton from thence along that agreed
 line So wt to Tho: Mackswells line thence along the said line to achesnut
 corner on David Heddlestons line from thence along the said Heddlestons
 S. E to Nathaniel Henderson line to a stake corner E from thence along
 the said Hendersons line to a red oak corner from thence S E along
 the said Hendersons to a pine corner from thence S. to Mathew Hawkins
 line to a stake from thence N. E. along said Hawkins line to the Begin
 ing A red oak corner containing 240 acres be the Same more or less it
 being a part of William Claytons Survey containing 574 acres Granted
 from the State bearing date February the 19th 1791 Together with all
