more or less together with all and singular the rights members here deterrments
and appertainances to the same or in any wise Incident or appertaining
to have and to hold all and singular the premises above mentioned unto
the said Joseph Goodgion his heirs and assigns forever and I do hereby bind
myself my heirs Executors and administrators to Warrant and forever defend all
and singular the premises above mentioned unto the said Joseph Goodgion his
heirs and assigns against myself and my heirs and against Every person
Whomever lawfully blaming or to blame the same or any part thereof

Lord one thousand Eight hundred and thirty two and in the fifty sixth
