Greenville District <sup>3</sup> of the State and district aforesaid have Granted Barg-  
ained and Sold and by these presents do Grant Bargain and Sell a certain  
tract or parcel of Land laying and being in the aforesaid State and district  
unto (ols) William Center for and a inconsideration of one thousand dollars to me  
in hand paid the Receipt Whereof is hereby fully acknowledged and by these pre-  
-sents doth Bargain and Sell the same laying and being on both sides of Gwyn-  
buck Waters of South Pacolet being part of Survey laid out and granted unto  
Samuel McClure and from him Granted and Conveyed unto John Peace Jun  
and from him Executed by A.W. Crowder Sheriff of Greenville for a Debt to  
the United States and Sold and purchased by the aforesaid Joseph Peace  
accepting about twenty acres or there about in the N.E. corner which was  
Granted and Conveyed unto John Evans by the aforesaid John Peace Jun  
before the date of said Execution and all the remainder I do Convey unto  
the Said William Center being by Estimation three hundred and Twenty six  
acres being by admeasurement and order from Court to Benjamin Griffith  
Eagr and Page Roark who Surveyed and platted the same on the 19<sup>th</sup> day  
of October 1818 Which by reference to their plat will more fully appear  
being the above said tract of land whereon the said Joseph doth now live  
and Whereas the said premises with their appertaining since the Seizure  
by me made A.W. Crowder by virtue of the Writ of Hieri Facias before mentioned  
have been Exposed to publick vendue for sale and purchased by Joseph  
Peace of the district aforesaid being the highest bidder therefor he there-  
fore has obtained the Sheriff Rights on the Seventeenth day of May 1823  
and by virtue of the same I the said Joseph Peace doth Grant Bargain  
and Convey unto the said William Center him his heirs and assigns  
to have and to hold the above piece parcel and tract of land with its  
appertaining unto from me my heirs Executors Administrators and Every  
of them or any person or persons lawfully claiming any part thereof  
in Witness Whereof I the said Joseph Peace have hereunto set my hand  
and Seal this twenty sixth day of June in the year of our Lord one  
thousana Eight hundred and twenty three
