presents That I Isaac Chandler of the district and State aforesaid for and in  
consideration of the Sum of one hundred and thirty four dollars to me  
paid by L H H Brock of the district and State aforesaid have granted  
Bargained Sold and released and by these presents do Grant Bargain Sell  
and release unto the Said L H H Brock two tracts or parcels of Land Viz  
first tract or parcel of Land conveyed by William Lankford to me Testator  
lying and being in the district and State aforesaid on the Northward Side  
of Road leading from Holley or otherwise now held by Owen and Vincent  
Jenkins Mill to Capt Thomas Springfield and on the South Side of  
Enoree River Beginning on a red oak corner on the side of the said Road  
at the head of a small Valley thence Northwardly a conditional line to a hickory  
3x on Samuel Styles line thence Westwardly on an open line binding  
on said Styles line to Black Jack 3x thence n<sup>o</sup> Southwardly on Styles and  
Elisha Green's line to a red oak 3x or to the said road before mentioned  
thence down the said road to the head of the Valley the Beginning corner  
stands in to a stake 3x thence to the Beginning altogether supposed to  
contain one hundred acres be the same more or less also a tract or parcel of  
Land conveyed by William Lankford to myself Supposed to contain twenty  
five acres be the same more or less Beginning on a red oak 3x on said Lankford  
line Between his Shop and Enoree River thence Northwardly to a red oak 3x  
on the South Bank of the said river thence down the different Meanders of  
the river to Holley Jenkins line thence Southwardly on said line to a red oak 3x  
on Jenkins Styles and Chandlers line thence Northwardly to the Beginning on  
Chandlers line Together with all and Singular the Rights members and ap-

gular the premises before mentioned unto the said Brock and do here-  
by bind myself and my Heirs Executors and Administrators to warrant and  
forever defend all and Singular the premises before mentioned unto the  
said Brock his heirs and assigns forever against myself and my heirs  
and against every other person whomsoever lawfully claiming or to claim  
the same or any part thereof we witness Whereof I have hereunto set my  
hand and Seal this 23<sup>rd</sup> day of November the year of our Lord 1832
