 Entered into Between William Norris and Martha Nelson of the one part  
 and James Pickett of the other part Witnesseth that the Said William  
 Norris and Martha Nelson do hereby receive of James Pickett five dollars  
 for which we the Said William Norris and Martha Nelson doth hereby  
 Sell and by these presents have Sold unto James Pickett all the land  
 and all the Improvements whereon we now live which line Beginning  
 on James Southerlins old maple corner and running <sup>west</sup> a West course with South  
 line old line to its Termination of Green that old line of the originally grant  
 of the Said Maple corner and thence and thence South to James Picketts  
 new line and thence on James Picketts line Back to the Beginning of Maple  
 corner and for the Said James Pickett to have and to hold all the Said  
 land to him and his heirs forever, all of which we the Said William  
 Norris and Martha Nelson doth warrant and defend the all the Said  
 land and premises to the Said James Pickett and his heirs forever  
 free and clear from us and our heirs or any other Lawfull claim what  
 soever against the Said Land and Improvements as Witness hereunto  
 we the Said William Norris and the Said Martha Nelson do Set our  
 Hands and affix our Seals this 2<sup>d</sup> day of July A.D. 1832 and in  
 the fifty sixth year of the Americans Independence &c Signed
