Salmon of right had of in and to the Same to have and to hold the Said piece parcel and tract of Land With its appertinances unto the Said Jeremiah Cleveland his heirs and assigns as fully and absolutely as I the Said William Blasingame might could or ought to Grant Bargain and Sell the Same by Virtue of the Statute aforesaid and the Said Writ of Hierifacias or otherwise In Witness Whereof I the Said William Blasingame have hereunto set my hand and Seal the 31st day of July in the year of our Lord one thousand eight hundred and thirty three Signed Sealed and delivered
