

This Indenture made this 31<sup>st</sup> day of July in the year one thousand  
Eight hundred and thirty three between Sarah Buckhanan of Win-  
chester Virginia Relict of the late Alexander P M Buckhanan of same  
town and of the one part and Vardry Mc Bee of the other part  
Witnesseth that the Said Sarah Buckhanan for and Inconsideration  
of the Sum of two hundred and fifty dollars to her in hand paid  
by the Said Mc Bee at and before the enrolling and delivery of these  
presents [The receipt whereof is hereby acknowledged and the  
Said Mc Bee thereof forever acquitted and discharged] hath  
Granted Bargained Sold aliened Enfeoffed released and confirmed  
and doth by these presents Grant Bargain Sell alien enfeoff release  
and confirm unto the Said Vardry Mc Bee his heirs and assigns  
forever all the right title and Estate Interest and demand  
Whosoever held and owned by the Said Sarah Buckhanan  
in and to the lands Tenements and Hereditaments now held  
by the Said Mc Bee at or near the town of Greenville in the State  
of South Carolina or heretofore held by him To have and to hold  
the lands and tenements hereby conveyed to the Said Vardry  
Mc Bee and his heirs forever and the Said Sarah Buckhanan for  
herself and her heirs hereby covenant to and with the Said  
Vardry Mc Bee that she the Said Sarah Buckhanan the lands and  
Tenements hereby conveyed unto the Said Mc Bee against all  
claim of her the Said Sarah and her heirs and of all persons  
blaming by through and under her shall and will warrant and  
forever defend by these presents, In Testimony of all which the
