State of South Carolina Know all men by these presents that I Joseph Green of the district of Greenville in the State aforesaid farmer, in consideration of the Sum of Seven hundred and Six dollars to me paid by John Green of Greenville district in the State aforesaid have Granted Bargained Sold and Released and by these presents do Grant Bargain Sell and Release unto the Said John Green all that tract piece or parcel of Land Situate in the district and State aforesaid on the North and South forks of Mountain creek of Enoree river containing one hundred and Seventy six and one half acres it being parts of two tracts of Land Originally Granted to Robert McAfee and Isaac Green and hath such marks &c as follows (Viz) Beginning at a P. O. 3x Robert McAfee's original corner thence S. 28.5 W. 41.40 chains to a stake 3x thence S. 60. E. 4 chains to a hickory 3x thence S. 17. W. 44. 6 chains to a cedar 3x thence due East across a mill pond on the S<sup>o</sup> fork of M<sup>o</sup> creek 25 chains to a fallen down pine 3x thence N. 22. E. 52. 90 across South fork of M<sup>o</sup> creek to a small Sassafras 3x in the Edge of an old field thence N. 36. E. across the north fork of M<sup>o</sup> creek 24. 20 to a small Hickory 3x thence N. 61. W. 23 chains to the Beginning Together With all and Singular the Rights members Here deterrments and appurtenances to the Said premises belonging or in any wise Incident or appertaining to have and to hold all and Singular the premises before mentioned unto the Said John Green his heirs and assigns forever and I do hereby bind myself my heirs Executors and Administrators to Warrant and forever defend all and Singular the Said premises unto the Said John Green his heirs and assigns against myself and my heirs and against Every person Whomsoever lawfully claiming or to claim the Same or any part thereof Witness my hand and Seal this nineteenth day of September in the year of our Lord one thousand eight hundred and thirty one and fifty sixth year of American Independence
