Now the condition of the above obligation is such that if the above Bounden Charles Jerry does live and continue with Ann Jerry our mother untill her decease does make and furnish her with a good and comfortable support during her life time pay or cause to be paid unto John M^d. Jerry Sabey Jerry Asberry Jerry William Meares Gaston Jerry and Hannah Jerry our heirs or assigns the sum of Seven hundred and forty dollars to be paid at her our mothers Decease then to be divided among the heirs (Say John M^d. Jerry Sabey Jerry Asberry Jerry William Meares Gaston Jerry and Hannah Jerry so as to make us all Equal in the divide of our fathers and mothers Estate Say only our mothers Estate there we do bind and obligate ourselves Say John M^d. Jerry Sabey Jerry Asberry Jerry William Meares Gaston Jerry and Hannah Jerry our Executors and Administrators to make good and lawfull titles to the Said Charles Jerry to the land on which our mother now lives containing three hundred and three acres and a half more or less lying and being in the State and district aforesaid in the Neighbourhood of the fork Shoals to Warrant and power defend the Same from the claim of ourselves Executors and Administrators and from the claim of Every other person or persons lawfully claiming or to claim the Same or any part thereof unto the Said Charles Jerry his heirs or assigns forever We John M^d. Jerry Sabey Jerry Asberry Jerry William Meares Gaston Jerry and Hannah Jerry do further more agree and bind ourselves Executors Administrators or assigns in the sum of one thousand dollars to be paid to the Said Charles Jerry his heirs or assigns if any Circumstance should occur to prevent us from making the above named titles to the Said Charles his heirs or assigns at the above mentioned time We also agree that the Said Charles is to have the use and priviledge to appropriate to his own Emolument all and Every thing he may make on the land during our mothers life time over and above the Support before mentioned then this obligation to be void and of non Effect otherwise to remain in full force
