of the district of Greenville in the State aforesaid have Granted Bargained sold
and conveyed and by these presents do Grant Bargain Sell and Convey unto
the Said William Goldsmith a certain tract or parcel of land lying and
being in the in the district of Greenville in the State aforesaid and containing
two hundred and fifty nine acres and bounding and butting as follows
Beginning at a hickory on the road 37 and running N. 31. E. 17. 50 to a gum 37 thence
N. 60, W. 24. 50 to a red oak 37 thence S. 74, W. 16. 50 to a red oak 37 on the Road
thence with the road to a post oak 37 thence N. 61, W. 25. 50 to a red oak 37
thence S. 30, W. 25. 75 to a red oak 37 thence S. 36, E. 49 to a stake at the corner
of Lot No 2 thence S. 86. E. a straight line to the Beginning corner Includ
ing the Dwelling House in which the late Colo William M Brymes Deced
did live it being the same tract of land that William Choise as Com
missioner in Equity for Greenville district conveyed to Samuel B
White by Deed bearing date the 3rd day of December 1829 and conveyed
to Daniel Wallace by said White by deed bearing date 10th day of February
1832 and conveyed to Thomas Brymes by Daniel Wallace by ~~and~~
deed bearing date 18th January 1834 Together with all and singular
the rights members Hereditaments and appertinances to the Said premises
belonging or in any wise Incident or appertaining to have and to hold
all and singular the premises before mentioned unto the Said William
Goldsmith his heirs and assigns forever and I do hereby bind myself
my heirs administrators Executors and assigns to Warrant and forever
Defend all and singular the above described premises unto the Said William
Goldsmith his heirs and assigns against myself and my heirs and against
all persons whomsoever lawfully claiming or to claim the same or any
part thereof Given under my hand and seal the 18th day of January on
Thousand Eight hundred and thirty four and in the 58th year of the Inde
pendence of the united States of America
