Junr a parcel or tract of land containing one hundred acres be the  
same more or less it being a part of a tract of one hundred and thirty  
five acres granted to Andrew Mcnight on the first day of December  
1788 Situate and laying in the State and district aforesaid on the  
south fork of Rabana Creek Waters of Needy River and Beginning  
on a hickery or on said Creek thence S. 85. W to a post oak or thence S. to  
a hickery or thence E to a post oak or then the original line to a  
hickery or then the original line to the Creek thence down the Mean-  
-der of said Creek to the Beginning hickery to include one hundred  
acres of land be the same more or less together with all and singular  
the rights members Hereditaments and appurtenances to the said  
premises belonging or in any wise incident or appertaining to have  
and to hold all and singular the premises before mentioned unto  
the said Edward Nash Junr his heirs and assigns forever and  
I do hereby bind myself my heirs Executors and administrators  
to warrant and forever defend all and singular the said premises  
unto the said Edward Nash Junr his heirs and assigns against  
myself and my heirs but no other witness my hand and seal  
this twenty seventh day of December in the year of our Lord  
one thousand eight hundred and twenty one and in the forty  
sixth year of the Independence of the united States of America
