 to us jointly paid in hand by James L Springfield the receipt whereof
 We do hereby acknowledge hath granted bargained sold and released
 and by these presents do Grant bargain seal and release unto the
 Said James L Springfield a certain tract or parcel of Land containing
 two hundred and seventy five acres be it the same More or less situ-
 ate in the district and State aforesaid on a branch of Enoree
 River Lines begining on a P. O. Thence S 70 E 15 1/2 to a corner
 thence along a conditional line to a W. O. on a branch a conditional
 & thence down the meanders of said branch to a large Poplar a
 conditional corner of Jacob Glazys former land thence S 65 W
 3 1/2 E to a red oak on the road thence along the old road nearly
 a South course to a lightwood Stake corner thence S 81. W to a red oak
 thence to a red oak a conditional corner on Burnses land thence
 N 60. W. 18 Chain 75 links to a stake near the forks of a small branch
 thence up the meanders of the West fork of said branch to an oak
 corner thence N 64 W 12 Chain 50 links to a lightwood Stake on
 a path thence along said path to a stake on Blackwells old line
 thence with said line to a red oak corner thence a straight line
 to Robert Princes original P. O. corner the begining being part of
 two tracts of land granted to Robt Prince and John Gubb together
 with all and singular the rights members Hereditaments and
 appurtenances to the said premises or in any wise incident
 or appertaining to have and to hold all and singular the premises
 before mentioned unto the said James L Springfield his heirs and
 assigns forever and we do hereby bind ourselves our heirs Executors

 and assigns against ourselves our heirs Executors and Administrators
 and against all and Every person or persons Whomsoever lawfully
 claiming or to claim the same or any part thereof In Witness
 Whereof We have hereunto set our hands and affixed our seals this
 16th day of August A. D. 1833.
