said Mayfield all that tract or parcel of Land containing three hundred
and fourteen acres more or less situate on both sides of the Gap Creek Road
and including branches of the long Branches of Thompsons River and Creek of
Middle Tyger and branches of the South fork of Tyger River Bounding Eastward
on land originally granted to Arthur Satwford Southwardly on James Shatto
Land West by land claimed by Sloan and North on land call'd Lovis
Together with all and Singular the rights members Hereditaments and
appurtenances to said tract of three hundred and fourteen acres belonging
or in any wise Incident or appertaining to have and to hold all and
singular the premises before mentioned unto the said Mayfield his heirs &
assigns forever and I here by bind myself my heirs Executors Administra-
tors to Warrant and forever defend all and Singular the said premises
unto the said Mayfield his heirs and assigns against myself my heirs
and against every other person whomsoever lawfully claiming or to claim
the same or any part thereof as witness my hand and seal in the year
of our Lord one thousand eight hundred and thirty two and fifty sixth
year of the American Independence this 22nd day of September 1832
