Cleveland all that tract or parcel of land situate in the district and State
aforesaid on branches of Saluda River between the Pendleton and White
horse roads containing seventy three acres and hath such bounds marked
as follows (viz) Beginning at a stone 3x on a branch thence N. 54. E. 43. 50
chains to a P. 3x thence N. 32. W. 34 chs to a P. 3x near the head of
a branch thence S. 17 W. 58 chains to the beginning corner it being part
of a tract of land originally granted to James Settle the above description
will more fully appear on reference to a plat herunto annexed. Together with
all and singular the rights numbers & encumbrances and appertaining
to the said premises belonging or in any wise incident or appertaining
to have and to hold all and singular the premises before mentioned
