State of South Carolina } Know all men by these presents that I Absalom  
Greenville District } Carney of Greenville District in the State aforesaid  
in Consideration of the Sum of one hundred and Sixty dollars to me paid  
by Dr Burrell Chick of the district aforesaid have granted Bargained sold  
and released and by these presents do Grant Bargain sell and release  
unto the said Dr Burrell Chick all that tract parcel or piece of Land it  
being part of a tract of Land originally granted to Absalom Carney aforesaid  
situate in said district on the South Side of Enore River containing Seven  
ty Eight acres more or less and hath such bounds &c as follows Viz beg  
inning on said river at the mouth of Carneys Spring Branch thence up  
said Branch to the head thence S. 2. W. 3 chains to a small P. O. or thence S 85  
E 33. 87 chains to a hickery or thence N. 3 W about 20 chains to Enore River  
thence up said River to the Beginning] Together with all and singular the  
rights members hereunto and appertaining to the said premises  
Belonging or in any wise Incident or appertaining to have and to hold  
all and singular the premises before mentioned unto the said Dr Burrell  
Chick his heirs and assigns forever and I do hereby bind myself my  
heirs Executors and Administrators to warrant and forever defend all  
and singular the said premises unto the said Dr Burrell Chick his  
heirs and assigns against myself and my heirs and against every  
person whomsoever lawfully claiming or to claim the Same or any part  
thereof Witness my hand and Seal this twenty ninth day of September  
in the year of our Lord one thousand Eight hundred and thirty four  
and in the fifty ninth year of the Independence of the united States  
of America
