John Hodges of the State of South Carolina & Greenville district having
this day granted bargained sold and delivered & do hereby grant bargain
sell & deliver unto the said John Hodges a certain tract or parcel of land
situate lying and being in the district of Greenville & State of South Carolina
on the waters of Hightowers mill creek or Jerry's creek waters of Saluda
River adjoining the North Carolina line in the gap leading from High
towers to Fords old quarter place containing an hundred or twenty
acres more or less which was originally granted to William Corbin
in a survey of two hundred and twenty acres together with all its
waters woods appurtenances thereunto belonging or in any wise
appertaining to have and to hold all and singular the above
named premises unto the said John Hodges his heirs Executors
Administrators or assigns and we hereby bind ourselves our
heirs Executors and administrators to warrant and forever
defend the same from all person or persons lawfully claiming
or any part thereof in witness whereof we have hereunto set our
hands & seals this 19th day of March A.D 1835 Sarah Kilpatrick
