State of South Carolina Know all men by these presents that I Wadley Webb of North Carolina for in consideration of the Sum of Six hundred and thirty Six dollars to him in hand paid by William Wickliffe of Greenville District and Village of Greenville in the State of South Carolina the receipt and payment whereof is hereby acknowledged have Granted bargained Sold and Conveyed and doth by these presents Grant bargain Sell and Convey unto the said William Wickliffe a certain tract of land lying on the Waters of Mountain Creek being surveyed and laid off as follows (Viz) beginning on a Spanish oak in the Bottom on the North Side of Mountain Creek and runs thence South 13 chains 75 links to a pine not thence South 85 East 86 chains 75 links to a pine not thence North 49 chains to a large pine on the South Side of the Road thence N 77. W. S. 30 to a pine stump by a black Jack thence South 80. W. 15. 50 to a hickory thence North 39 W 16 chains to a fallen down Pine thence West 9 chains and Sixty links to a stake thence South 15 chains to a post oak thence South 65 West 42
