 wherein I am concerned or that in any wise concerns me Par
 ticularly to Sell tract of Land containing two hundred and
 Sixty four acres more or less Situate in Greenville District on
 Mill Shoal Creek fork of Inoche River being a part of the real
 Estate of Robert Benson (Deceased) which Said Land I purchased
 of my brother James M Crawford who now holds the rights of
 the Same and is to make titles to any person that may Purchase the
 Same and I do hereby Invest my Said Attorney with full Power
 and Authority to make Settlements Sue and defend Suits receive
 and convey titles receipt and receive receipts or do any other
 Lawfull act or deed for me and in my Name as fully and
 as firmly as I myself could were I personally present Witness my
 hand and Seal this 8th day of January 1835
