Relinquish the Same and I do hereby authorize Peter Gault the Execu-
tor of the will of the Said Alexander Vickers to proceed to sell and
Distribute the Estate of the Said Alexander Vickers without regard
to any provision made in the Said will for me and as though none
Such had been made Intestimony whereof I have hereunto set
my hand and Seal this 12th June 1835

N. 88. W. 11.50 to a stake corner N. 83th W. 15.30 to a dogwood corner bounding on
William Mayfield's Sr land N. 11th W. 11 to a hickory N. 42th E. 19.90 to the
beginning corner being the tract of land that A. Mayfield Sen now lives on
on the North Side of Enore river in the State and district aforesaid
binding on my own land and Daniel Woods and A. Mayfield's Sr
which includes the land to be conveyed be the Same more or less
