that plantation or tract of land situate lying and being in the district  
of Greenville in the State aforesaid on Chinguepin Creek Beginning  
at a dogwood corner and running thence N. 28. E. 21. 25 across the said Chinguepin  
Creek to a red oak thence N. 50 E. 26 to a stone thence N. 65. W. 25 to  
a P.S. marked as a pointer thence S. 75. W. 82 across the said Chinguepin  
Creek to a post oak thence S. 3. W. 16 to a stake and thence S. 62 E. 63 across  
the old Lutherford Road to the Beginning corner containing three hundred  
and thirty three acres more or less being the same tract Surveyed by John  
Watson Esqr The 30<sup>th</sup> July 1830 and a plat of which he returned to the Court  
of Common Pleas for Greenville and which was used in Evidence on the  
Trial of the Case of the Abram Markley, heirs against the said Reubin  
Ayres and recovery had of the same land now hereby Conveyed or  
will appear by reference to the said plat and the Certificate of W. P.  
Martin presiding Judge Thomson dated March Term 1832 Together
