forever Provided Nevertheless and it is expressly agreed between the Said
Parties that if the Said William Arnold his Executors Administrators or assigns
shall sell and truly pay or cause to be paid unto the Said Berry & Bolling &
Jerry J Bolling Fifty dollars with the lawfull interest from the date on or before the
first day of June next the above Bill of Sale and Every article therein contained
shall cease and be utterly void or of none Effect otherwise to remain in full force
and virtue in Law In Witness my hand and Seal this the first day of February
one thousand Eight hundred and thirty five Signed Sealed and delivered in the

Greenville district } State aforesaid for and in consideration of the love and kindness
which I bear towards my Son Jacob Green and also for divers Services to me rendered
by the Said Jacob I do hereby give to the Said Jacob a negro boy Child named
Pleasant about four years old at this time and I do hereby bind myself and
my heirs Executors or Administrators to defend the right of Said Negro against
the Lawfull Claims of all persons whomsoever And I do hereby invest the said
Jacob Green his heirs and assigns forever in the full right and title to the
Said Negro boy Pleasant to be the Said Jacobs property absolutely In Witness
whereof I have hereunto set my hand and Seal this 25th day of September A.D.
