 stake or bounded by the said Gundiff land thence N 30. 50 E 11 to the beginning
 bounded by David Berry's land it being part of the tract that the said Grigg
 Gundiff now lives on Together with all and singular the rights members here
 the said elements and appertinances to the said premises belonging or in any
 kind incident or appertaining to have and to hold all and singular the
 premises before mentioned unto the said James R Corley his heirs and assigns
 and to forever and I do hereby bind myself my heirs Executors and admors
 and assigns to Warrant and forever defend all and singular the said
 premises unto the said James R Corley against myself and my heirs &
 against every person whomsoever lawfully claiming or to claim the same
 and against any part thereof Witness my hand and seal this twenty eighth day
 of the 1st May in the year of our Lord one thousand eight hundred and
 thirty five and in the fifty eighth year of the Independence of the
 United States of America
