sum of five hundred dollars to me paid by John H. Clark
of the S State and District the receipt whereof I acknowledge have granted bargained
sold and released and by these presents do grant bargain sell and release
unto the S John H. Clark a certain tract or piece of Land containing one hundred
and ninety two acres more or less lying and being in Greenville District and
State aforesaid on a small branch of Reedy River and bounded by lands
of the heirs of Walter Ashmore de heirs of James McKenzies Isaac Cox myself
and John Smith commencing on a stake on Smiths land on the mill road
thence down the road to a pine stump corner on McKenzies land thence S 16
W 13.50 to a stake on the Branch thence up the S Branch to a maple thence S 14
W 14 1/2 to a stake thence S 1/2 on bones line to a Post oak on upland thence on my
land thence on my line to a stake on Smiths land thence on Smiths line to the
beginning the same being granted to John Safford in the year of our Lord one thousand
Eight hundred Eighty Eight being conveyed to different hands down to the said
John H. Clark together with all and singular the matters hereinaunt and appertaining
in and to every part and parcel thereof The rights and title whereof
I the S Samuel Hicks my heirs Executors and administrators unto the
John H. Clark his heirs Executors administrators and assigns shall and
will forever defend August - 23 - 1836
