hand paid by Joseph McCullough of the state and district aforesaid have granted
bargained sold and released and by these presents do grant bargain sell and re-
-lease unto the said Joseph McCullough all that parcel of Land being in the state and
-district aforesaid on the waters of Little horse creek - waters of Ruddy River beginning
on a black gum 3x on a small branch and running thence N 83 E 15 to a Hickory
3x thence N 22 E 16 50 to a Pine 3x thence N 68 E 11 to a red oak 3x binding on Henry G. John-
-son Land thence S 57 1/2 E 19 75 to an ash 3x on a Branch thence down the meander
of P Branch to a willow 3x on a small creek thence up the meanders of said creek
to a Stake 3x thence S 21 W 16 50 to a dogwood 3x thence N 60 W 35 to a maple on
a Branch thence up said Branch to the Beginning bounded on Joseph McCullough
-of Land containing one hundred and thirty one acres more or less together with
all and singular the rights members hereunto appertaining to the said
-belonging or in anywise incident or appertaining to have and to hold all and sing-
-ular the premises above mentioned unto the said Joseph McCullough his heirs
-and assigns forever and I do hereby bind myself my heirs Executors and admi-
-istrators to warrant and defend all and singular the premises above
-mentioned unto the said Joseph McCullough his heirs and assigns against
-myself and my heirs and against every other person whomsoever lawfully
-claiming or to claim the same or any part thereof Witness my hand and seal
-this the third day of November in the year of our Lord one thousand eight
-hundred and thirty five Signed sealed and delivered in the presence
