 Whereas by virtue of Summons writs of Fieri Facias issued out of the court of Common  
 Pleas held for the district of Greenville tested the full Term 1836 in the year of our  
 Lord one thousand eight hundred and twenty six at the suit of R. F. Perry  
 and Nathan Perry Separate Suits to me directed, commanding me that of the lands  
 and Chattels Lands and Tenements of John S. Clark to levy the sum of forty dollars  
 damages and costs I have seized and taken of the said and Tenements of  
 the said John Clark all the certain piece parcel and tract of Land contain-  
 ing one Hundred and Eleven acres situate and being in the district  
 of Greenville on the waters of Reddy River as belatedly adjoined Lands  
 of Joseph McCullough it being the same tract and parcel of Land whereon  
 the defendant John S. Clark lives and whereas the said premises with their  
 appurtenances since the seizure by me made by virtue of the said writ of Fieri  
 Facias before mentioned have been Exposed to sale at public auction and purchas-  
 ed by Michael Thompson of the District of Lawrence for the sum of fifteen  
 dollars being the highest sum was bid and therefore Now Know ye that  
 I James McDaniel Sheriff aforesaid by virtue of the said writ Fieri Facias  
 aforesaid to me directed and delivered as aforesaid and by virtue of the  
 Statute in such case made and provided and for and in consideration  
 of the said sum of fifteen dollars to me in hand paid or secured  
 to be paid by the said Michael Thompson the receipt and payment  
 whereof I do hereby acknowledge have granted bargained and sold  
 acknowledge have granted bargained and sold and by these presents  
 do grant Bargain and sell unto the said Michael Thompson his  
 heirs and assigns forever the said tract piece and parcel of Land with  
 its appurtenances and all the estate right title and interest which the  
 said John S. Clark of right of in and to the same So have and to  
 sold the said piece parcel and tract of Land with its appurtenances  
 unto the said Michael Thompson his heirs and assigns forever as fully  
 and absolutely as I the said James McDaniel might could or ought  
 to grant Bargain and sell the same by virtue of the Statute aforesaid  
 and the said writ of Fieri Facias or other wise. In Witness whereof I  
 the said James McDaniel have hereunto set my hand and seal this fifteenth  
 day of July in the Year of our Lord one thousand eight hundred and  
 thirty six signed sealed and Delivered in presence of
