

The State of South Carolina Greenville District To All to whom these presents shall come, or be made known, Know ye that whereas my Brother George Croft of the District and State aforesaid at the date of these presents stands indebted unto me the undersigned Edward Croft in and by his Bond or Obligation bearing date the ninth day of November in the year of our Lord one thousand eight hundred and thirty seven in the sum of Three thousand six hundred and fifty dollars conditioned for the payment of one thousand eight hundred and thirty dollars on or before the first day of January, which will be in the year of our Lord one thousand eight hundred and forty, with lawful Interest from the date of the said Bond, which said Bond or Obligation is secured to me by the Mortgage of the following Negro Slaves namely Syke, Hannah Aaron and Phillis together with the sum of one and no more of the sum of one hundred and thirty dollars that I the undersigned Edward Croft for and in consideration of the Natural Love and affection which I bear unto my Brother George Croft and to his Children Edward Croft who bears my name and is called after me Clenland Croft Elizabeth Love the said Croft and Mary Isabella Croft and also for and in consideration of the Natural Love and affection which I bear unto Alice Rullage Croft the daughter of my Nephew the aforesaid Edward Croft and also for and in consideration of one dollar to me retained in hand paid at and before the sealing and delivery of these presents by George Croft aforesaid the receipt whereof I do hereby acknowledge have granted bargained sold set over and assigned and by these presents do grant bargain sell set over and assign the aforesaid Bond and Mortgage together with all the rights and privileges in Law and Equity which I have in the said Bond and Mortgage unto R. M. Pearson, R. Croft and Theodore G. Croft their heirs Executors administrators and assigns for use in Trust always nevertheless to and for the uses, purposes limitations and intentions hereinafter expressed To wit my said Assigns as their heirs Executors administrators or assigns shall at the end of every year execute and deliver to my said Brother George Croft a receipt or discharge in full for the Interest which shall be due on the said Bond, it being my intention to give up to my said Brother, all the Interest on the said Bond except as hereinafter excepted in Trust also that they my said Assigns shall on the first day of January which will be in the year of our Lord one thousand eight hundred and forty collect or cause to be collected on that day or as soon thereafter as practicable the sum of Four hundred South Dollars and pay over the same to such person as shall be legally qualified to receive the same for the sole use benefit and behoof of Alice Rullage Croft and her heirs by requiring my said Assigns to charge and collect the Interest on the said Four hundred and forty dollars such time as shall elapse after the said first day of January last aforesaid before the said Four hundred dollars shall be collected should the said George Croft not pay the same on the very day herein required which Interest they shall pay in the same manner and for the same purposes as the said Four hundred dollars in Trust also that from and after the said first day of January which will
