Greenville District 3, of the Town of Greenville in the State aforesaid for and in consid  
eration of the sum of five hundred Dollars to me in hand paid by Green Ingram  
of Town and District aforesaid in the State aforesaid have granted, bargained, sold  
and released and by these presents do grant, bargain, sell and release, unto the  
said Green Ingram all that lot in the Town of Greenville being  
in the South East square of said Town beginning at a stake on Main  
Street and runs South 74 degrees East 176 feet to a stake, thence South 10  
100 feet to a stake, thence North 74 degrees West 176 feet to a stake on  
the main street, thence along the main street 100 feet to the beginning  
it being the house and lot lately occupied and improved by J. H. Wenne  
dict Together with all and singular the rights members hereditaments  
and appurtenances to the said premises belonging, or in any wise incident  
or appertaining To have and to hold, all and singular the  
premises before mentioned, unto the said Green Ingram his Heirs and assigns  
for ever. And I do hereby bind myself my Heirs, Executors & Administra  
tors, to warrant and for ever defend, all and singular the said premises, unto  
the said Green Ingram his Heirs and assigns, against me and my heirs,  
and against every person whomsoever. I lawfully claiming or to claim  
the same, or any part thereof. Witness my hand and seal, this first  
day of August in the year of our Lord one thousand eight hundred and  
thirty seven and in the sixty second year of the Independence of the United  
States of America signed sealed and delivered in the presence of  
Wardry M Bee  
South Carolina 3 Personally appeared Isaac H. Benedict before  
Greenville District 3 me, and made Oath, he did see Wardry M Bee  
sign, seal and as his act and deed deliver the within deed for  
the uses and purposes therein set forth, and that M. B. Alexander with  
himself was a subscribing witness to the same. I H. Benedict  
sworn to and subscribed before me this first day of  
August 1837 M. B. Alexander of the Ex. off
