 wife of the District and State aforesaid for and in consideration of the sum of six hun-  
 dred and fifteen dollars to us in hand paid by John F. Hammett of the District  
 and State aforesaid. Have granted, bargained, sold and released, and by these presents  
 do grant, bargain, sell and release unto the said John F. Hammett all that plantation  
 or tract of land containing two hundred and forty 4/10 acres be the same more or less  
 It being part of a tract originally granted to George Slight, situate, lying and being  
 in the District and State aforesaid on the Maple Swamp waters of South River  
 over and waters of Enoree River. Beginning on a post oak 37 and dividing  
 line between George Green and Jesse Green above mentioned running thence S 85  
 E 45 Chains to a Spanish Oak 37 thence S 57 E 60 Chain to the original line  
 thence S 30 W 49 Chain to a red Oak 37 thence along the above dividing  
 line N 25 W 26 Chain and 40 links to a stake 37, thence N 6 W 19 Chains to  
 a Spanish Oak 37, thence S 45 W 7 Chains 50 links to a post oak 37 then  
 N 60 W 19 Chains 50 links to the beginning. Together with all and singular  
 the rights, members, hereditaments and appurtenances to the said premises belonging  
 or in any wise incident or appertaining to have and to hold all and singular  
 the premises above mentioned unto the said John F. Hammett, his heirs and  
 assigns forever and we do here by bind our selves our heirs Executors and  
 Administrators to warrant and for ever defend all and singular the said premises  
 unto the said John F. Hammett his heirs and assigns against our selves and
