 Alexander Junr thence to a stone corner made for said James Alexander Junr  
 and Alexander W Paden thence on said Paden's line to rock pile thence to ash on  
 the branch on said Paden's line thence up said branch to a black oak on said  
 Paden's line thence to black oak said Paden's line thence to the wagon Road  
 opposite Fairview Academy thence along said Wagon Road to the beginning  
 To have and to hold all and singular the premises above described unto  
 the said Alexander W Paden his heirs or assigns forever and I do hereby bind  
 myself my heirs Executors or administrators to warrant and forever defend the  
 same against myself my heirs or assigns and against every other person law-
