Provided Nevertheless and it is the true intent and meaning
 of the parties to these presents, that if, we the said John W Bredlove and
 Thomas G Dunlap do and shall well and truly pay or cause to be paid
 unto the said W Blasingame the said debt of six Hundred Dollars by
 the first day of December next (1839) and also the Interest thereon if
 any should accrue according to the true intent and meaning of the said
 note then this sale shall cease determine & be utterly null and void
 otherwise it shall remain in full force and virtue and it is agreed
