South Carolina Know all men by these presents that I John H Harrison for the sum
 Greenville District of one hundred ^{eighty} Dollars paid by John H Joyce have granted bargained
 sold and released and by these presents do grant bargain sell and release unto the said
 Joyce his heirs and assigns a tract or parcel of land in said District containing sixty nine
 acres be the same more or less being part of a tract originally granted to John B Kilpatrick
 on both sides of the Reddy fork beginning at a stake 37 on Berry's line N 100 19.50 to a post
 oak thence N 88 E 54.50 to a stone on Mr Harrison's line thence S 62 N. 52.50 to a stake
 on the creek thence N 66 W 8.50 to the beginning. To have and to hold the same as above
 described to the said Joyce his heirs and assigns forever. Together with all and singular the rights
 members hereditaments and appurtenance, to the same belonging or in anywise incid-
 ent or appertaining and I do hereby bind myself heirs Executors &c. to warrant & forever de-
 fend the same to the said Joyce and his against myself and mine and against every other person
 or persons lawfully claiming the same or any part thereof. In witness I have hereunto set
 my hand & affixed my seal this 7th of May 1835.

 of one hundred and seventy five Dollars to me paid by Jacob I Rhoads likewise of Greenville
 District in the State aforesaid have granted bargained sold and released and by these presents
 do grant bargain and sell and release unto the said Jacob I Rhoads All that Piece or parcel
 of land near the Village of Greenville Beginning at a stake by a pine corner of Capt
 Cleveland's & Genl W. Thompson Land thence North 7 1/2 Degrees W 330 feet to a stake
 thence South 16 Degrees West 174 feet to a stake, ^{the} South 7 1/2 Degrees East 274 feet to a
 stake on Cleveland's line thence North 33 Degrees East a long Cleveland's line 186 feet to
 the beginning. Together with all and singular the rights Members Hereditam-
 ents and appurtenance, to the said premises belonging or in anywise incident
 or appertaining. To have and to hold all and singular the premises
 before mentioned unto the said Jacob I Rhoads his heirs and assigns forever. And
 I do hereby bind myself, my heirs Executors and Administrators to warrant and defend
