And I do hereby bind myself my Heirs Executors and Administrators  
to warrant and forever defend all and singular the said premises unto the  
said Isaac H Benedict his Heirs and assigns, against myself and my heirs  
and against every person whomsoever lawfully claiming or to claim the same  
part thereof. Witness my Hand and Seal this fourteenth day of October in the  
year of our Lord One Thousand Eight hundred and Thirty nine and in the Sixty  
fourth Year of the Independence of the United States of America

South Carolina - To all to whom these presents shall come I David Henning Sheriff of Greenville District and State aforesaid send Greeting  
Whereas, by virtue of a writ of fieri facias, issued out of the Court of common  
pleas held for the District of Greenville tenth the 12 day of April in the  
Year of our Lord One thousand eight hundred and thirty eight at the suit of St  
B D Mauldin to me directed commanding me that of the goods and chattels  
lands and tenements of Runnels Dill to levy the sum of Thirty eight  
Dollars damages and costs I have seized and taken of the lands and  
tenements of the said Runnels Dill all that certain piece parcel and  
tract of land containing One hundred & fifty acres more or less situated  
and being in the District of Greenville on the Waters of South Tyger  
River wherein defendant now lives adjoining lands of Jefferson Burton  
Joseph Chastain and others - And whereas the said premises with their ap-  
partenances since the seizure by me made by virtue of the said Writ  
of fieri facias before mentioned have exposed to sale at publick value  
and purchased by Wesley Phillips of Greenville District for the sum of  
forty seven Dollars being the highest sum that was bid at therfore
