 to a stake corner thence S 7<sup>th</sup> E to a conditional post Oak corner thence  
 N<sup>o</sup> to a conditional post Oak corner thence to the beginning corner contain-  
 ing One hundred acres be the same more or less. Together with all and sin-  
 gular the rights members Hereditaments and appertanances to said prem-  
 ises belonging or in anywise incident or appertaining To have and to hold all  
 and singular the premises before mentioned unto the said Wesley Philips his  
 heirs & assigns for ever and I do hereby bind myself my heirs Executors & Admin-
