 District in the State aforesaid for an in consideration of the sum of thirty dollars
 to me in hand paid by Isaiah Hilde of the District and State aforesaid
 have granted bargained sold and released and by these presents do grant
 bargain sell and release unto Isaiah Hilde a plantation or tract of land
 containing four hundred and ninety two Acres lying and being
 situate in the District and State aforesaid on the North side of Saluda
 River originally granted to the said Gaudle by Patrons bearing date the
 thirteenth of October one thousand seven hundred and ninety eight
 beginning on Maple the N. 13 to Poplar S. 15 to Red Oak then N. 33 to Hickory
 then S. 20 E to Stake then S. 47 to corner then E 48 to corner then N. 9 W. 41
 chains to corner then S. 68 N. 29 chains to Chesnut thence to the Beginning
 containing four hundred and ninety two Acres together with all and
 singular the rights Members Hereditaments and Appurtenances to the said
 Premises belonging or in any wise incident or Appertaining to have and to
 hold all and singular the s. Premises unto the said Isaiah Hilde his heirs and
 Assigns for ever and I do hereby bind myself and my heirs to warrant and
 forever defend all and singular the s. Premises unto the said Isaiah Hilde his heirs & Assigns
 against myself and my heirs and from no other person or Persons whatsoever
