 Beginning at a Stake near the Buncombe Road a corner of Peter Gerards
 Lot and thence thence North 36 degrees West near the said Buncombe Road
 two hundred and twenty seven feet to a Stake on the Avenue leading to the said
 Vardry's Residence thence South 17 degrees West three hundred and nineteen
 feet and a half to a Stake on the side of said Avenue, thence South 36 degrees
 West One hundred sixty six and a half feet to a Stake Peter Gerards corner
 thence North twenty six degrees East two hundred and Eighty Nine feet to the
 Beginning, containing by Estimation one acre and twenty five poles
 be the same more or less. Together with all and singular the rights members
 hereditaments and appurtenances to the said Premises belonging or in anywise
 incident or appertaining. To have and to hold all and singular the Premises
 before mentioned unto the said Henry M. Earle his heirs and Assigns forever
 And I do hereby bind myself my heirs Executors and Administrators to
 warrant and forever defend all and singular the said Premises unto the
 said ^{Henry} M. Earle his heirs and Assigns against myself and my Heirs &
 against every person whosoever lawfully claiming or to claim the same or
