 dollars to me paid by Thomas Povel of the same place in the State aforesaid
 have granted bargained sold and released & by these presents do grant
 bargain sell & release unto the said Thomas Povel. All that Lot of Land
 near the Village of Greenville. Beginning at a Stake a Corner of a Lot sold
 to J. V. Jennings near the Blucombe Road & Runs thence along the side
 of the road South 36 1/2 degrees East 208 1/2 feet to a Stake near the said Road
 thence South 53 1/2 degrees West 417 feet to a Stake thence North 36 1/2 degrees
 West 208 1/2 feet to a Stake thence North 53 1/2 degrees East 417 feet to the Begin-
 ning - containing two acres of land more or less whereon the said
 Thomas Povel now Resides.

Together with all and singular the rights Members. Hereditaments
 & Appurtenances to the said premises. belonging or in anywise incident
 or Appertaining To have and to hold all and singular the Premises
 before mentioned unto the said Thomas Povel his Heirs and Assigns
 forever And I do hereby bind myself my Heirs. Executors & Administrators.
 to warrant and forever defend all and singular the said Premises
 unto the said Thomas Povel his Heirs & Assigns against myself &
 my Heirs and against every person whomsoever lawfully claiming or to
 claim the same or any part thereof. Witness my hand & Seal this four-
 teenth day of August in the Year of Our Lord One thousand eight
 hundred and forty and in the fifty fifth Year of the Independence
