 Greenville listed the Fifth day of April in the Year of Our Lord
 One thousand eight hundred and forty at the suit of M. P. Popp
 vs Peter R. Popp to me directed commanding me that of the Goods

 to be paid by the said Elias Bill the receipt & payment whereof I do
 hereby acknowledge, have granted bargained sold and by these presents
 do grant bargain and sell unto the said Elias Bill his heirs and

 Appurtenances and all the estate right title and interest which
 the said Peter R. Popp of right had of in and to the same
 So have and to hold the said piece parcel and tract of land
 with its Appurtenances unto the said Elias Bill his heirs
 and Assigns forever, as fully and absolutely as I the said Sheriff
 might could or ought to grant bargain and sell the same
 by virtue of the statute aforesaid and the said Writ of Fieri
