 Dist. and State aforesaid. on theuddy fork Waters containing one hundred
 Acres more or less. (with) beginning at a Rock 3x on the trail Road and running
 N. 80 1/2 E 57.00 chains to a Rock 3x thence S. 35. W. 35 1/4 chains to a Rock 3x. thence
 N. 57 1/2 E 18 1/2 to a Poplar 3x. Thence S 65 W. 28 1/4 chains to a Stake 3x. Thence N. 7 E 23
 chains to a Rock 3x. Thence N. 83 E 2.10 chains to the Beginning
 Together with all and singular the rights members and appurtenances thereto
 unto belonging or in anywise incident or appertaining. To have and to hold
 all and singular the premises above mentioned and described unto the said
 Adam Jones his heirs or assigns forever. And I hereby bind myself my
 heirs Ex^{ors} and administrators to warrant and forever defend all and
 singular the said premises unto the said Adam Jones his heirs or assigns
 against myself and my heirs and against all and every person claiming
