Philips of the same State and District. have granted, bargained, sold
and released, and by these presents do grant, bargain, sell and release

-taining eighty two acres, be the same more or less, situate in said district
on the waters of Noddy River, it being three small tracts of land, two of

-dred and thirty four and the other conveyed to the said S. P. Philips
