of Seven hundred Dollars to me paid by Isaac Kirby of the said
State and District aforesaid have granted, bargained, sold and released and by
these presents do grant, bargain sell and release, unto the said Isaac Kirby a
plantation and tract of Land laying in the State & district aforesaid on the waters
of Mountain Creek of Saluda River - Beginning on a Sowwood 3X
thence running S 2 W 31 to a Red Oak 3X dead, bounded by William
Devonport and crossing the Augusta road; thence N 50⁴⁴ 7.71 to a Stake 3X
thence S 50⁴⁴ 7.38 to a Chestnut bounded by Tully Botting thence N 96 20 to a
stake 3X thence N 80 E to R 3X thence N 37 10 3 to a R 3X thence S 50 E. 3R 3X
on the line running N 80 E so as to leave out a Spring thereon Continue said
line "whole distance" 30.50 to the beginning - Containing Ninety three acres be the
same more or less - Together with all and singular the rights, members,
hereditaments and appurtenances to the same belonging or in anywise incident
or appertaining to have and to hold all and singular the said premises unto
the said Isaac Kirby his heirs and assigns forever and I do hereby bind myself
and my heirs to warrant and forever defend all and singular the abovementioned
premises unto the said Isaac Kirby from myself and my heirs (but
no further) Witness my hand and seal this 24th day of November
in the year of Our Lord one thousand eight hundred and forty and
in the sixty fifth year of the Independence of the United States of Amer-
ica Signed sealed acknowledged and delivered in presence
of Lewis H Shumate, Tully Botting  Vincent Austin
