January One thousand Eight hundred and forty and purchased
by David Hoke for Eleven & 50/100 Dollars. and assigned by him to John
Cochran the receipts for the purchase money having been
presented and filed as No 184. (see receipt)

And whereas the said premises with their appurtenances
since the seizure by me made, by virtue of the said Writ of Fieri
Facias before mentioned, have been exposed to sale at public
vendue and purchased by David Hoke for John Cochran of
the District and State aforesaid. for the sum of Eleven Dollars
and fifty cents, being the highest sum that was bid therefor.
Now know Ye that I the said N. M. Goddett Sheriff aforesaid, by
virtue of the said Writ of Fieri Facias aforesaid, to me directed
and delivered as aforesaid, and by virtue of the Statute in such
Case made and provided, and for and in consideration
of the said sum of Eleven Dollars and fifty cents to me in
hand paid, or to be paid by the said David Hoke
for John Cochran the receipt and payment whereof I do
hereby acknowledge, have granted bargained and sold and by
these presents do grant bargain and sell unto the said David
Hoke for John Cochran his heirs and assigns forever, the said
tract piece and parcel of lands, with its appurtenances
and all the estate right title and interest which the said
N. S. Morgan, of right had of in and to the same.

To Have and to hold the said piece parcel and tract of land
with its appurtenances unto the said David Hoke for John
Cochran his heirs and assigns forever as fully & absolutely
as I the said N. M. Goddett Sheriff as aforesaid might could
or ought to grant bargain and sell the same, by virtue of the
Statute aforesaid, and the said Writ of Fieri Facias or
otherwise, In Witness whereof, I the said N. M. Goddett Sheriff
have hereunto set my hand and seal the tenth of March in
the Year of our Lord One thousand eight hundred and forty
