 of Six Hundred & twenty five Dollars to me paid by William C
 Gurnells of the same place have granted bargained sold and
 released and by these presents do grant bargain sell and
 release unto the said William C Gurnells all that plantation
 or tract of land lying in the State and District aforesaid
 on the North side of Reedy River originally granted to James
 Floyd and acquired by Governor Matthews on the fourth day of
 December A. D. One thousand seven hundred and eighty six
 containing one hundred and ninety seven Acres (more or less)
 beginning on a Poplar 3x on a branch and running thence East
 11.00 to a Red Oak 3x bounded by Jeremiah Hopkins Land
 thence S 87 E 60.50 to a Stake 3x bounded by S Hopkins L. P. F
 Baker thence North 8.00 to a Stake 3x bounded by Robert Peas
