 ses as are hereinafter mentioned expressed and declared of and concerning  
 the same. Now this indenture witnesseth that in pursuance of the said  
 agreement in consideration of the said intended marriage and for and  
 in consideration of the sum of Five dollars to the said Thomas H. Todd  
 in hand well and truly paid and also the sum of Five dollars to the said  
 Burchet R. Roper in hand well and truly paid by Joseph S. Todd of  
 Mississippi and Isham R. Houze of Tennessee above before the sealing and  
 delivery of these presents the receipt whereof is hereby acknowledged the  
 said Burchet R. Roper by and with the privity and consent and approba-  
 tion of the said Thomas H. Todd her intended husband testified by his being  
 a party to and signing and sealing of these presents hath granted bargained  
 sold and assigned transferred and set over and by these presents doth grant  
 bargain, sell, assign, transfer and set over unto the said Joseph S. Todd  
 of Mississippi and Isham R. Houze of Tennessee and the survivor of them  
 the Executors, Administrators and assigns of such survivor all the follow-  
 ing named slaves. Morris, Mattison, Emanuel, Jane and her child and  
 the future increase and issue of the females. all her interest in some  
 Lands in Madison County Alabama her interest in moneys due her from  
 her grandmother Mrs. Ropers estate. also all her notes and moneys in  
 hands of her late guardian together with the household furniture and  
 live stock belonging to her the said Burchet R Roper as well as any  
 legacy or estate of inheritance which she may hereafter be entitled to  
 from her grandfather or any one else. and all her estate right title and  
 interest of in and to the same and every part thereof. To have and to  
 hold said Slaves, lands, moneys, notes, household furniture, live stock and  
 future legacies and estates of inheritance aforesaid with the future increase  
 & issue of the female Slaves unto the said Joseph S. Todd and Isham R. Houze  
 and the survivor of them and the Executors, Administrators and assigns of  
 such survivor forever. Upon such trusts nevertheless and to and for such  
 uses intents and purposes as are herein after expressed and declared of and  
 concerning the same that is to say. In Trust for the said Burchet R Roper her  
 Executors, Administrators and assigns until the solemnization of the said inten-  
 ded marriage and from and immediately the solemnization thereof then  
 In Trust that the said Joseph S. Todd and Isham R Houze and the sur-  
 vivor of them, the Executors, Administrators and assigns of such survivor  
 do and shall permit and suffer the said Thomas H. Todd during the  
 joint lives of himself and the said Burchet R. Roper his intended wife  
 to have the occupation, enjoyment, direction and management of the

 the lands, moneys, notes, household furniture, live stock future legacies and
