

estates of inheritance and other property above mentioned but so as the same shall not in any manner be liable or subject to his debts, contracts or engagements, and to receive and take the profits, proceeds and emoluments and advantages of the work of the said Negro Slaves the use and interest of the said moneys and notes, the rents of the Lands and use of the Household Furniture and live Stock and the use and interest of the future legacies & estates of inheritance for their joint use and benefit and in case the said Burchet R. Roper should survive the said Thomas H. Todd her intended Husband then In Trust that the said Joseph S. Todd and Isham R. Hooper and the survivor of them and the Executor, Administrator and assigns of such survivor Do grant convey and assign and transfer all and singular the said property above mentioned unto the said Burchet R. Roper her Executor, Administrator and assigns absolutely and forever freed and discharged of and from all and further and other trusts - But if it should happen that the said Burchet R. Roper should die before the said Thomas H. Todd leaving a child or children living at her death then In Trust that the said Joseph S. Todd and Isham R. Hooper and the survivor of them and the Executor, Administrator and assigns of such survivor Do grant convey and assign and transfer all and singular the said property above mentioned unto the said child or children of the said Burchet R. Roper living at her death and their heirs for ever. And in case the said Burchet R. Roper should depart this life before the said Thomas H. Todd her intended Husband without leaving issue or children living at her death then In Trust for her the said Burchet R. Roper to will, devise and dispose of as she may see proper in her lifetime absolutely and forever. Provided always that if any or either of the said Slaves and the future issue and increase of the females should misbehave him or herself or it should be hereafter be found most beneficial and to the advantage of the mutual interest of the said Thomas H. Todd and Burchet R. Roper his intended wife to sell or dispose of the said negro Slaves or some of them, or the Lands, household furniture, livestock or any of the property above mentioned in exchange for other property or to purchase other property with the moneys and notes already mentioned that it shall and may be lawful so to do provided the money arising from the sale of the same be laid out for other property to be settled conveyed and assured upon the said trust. AND the said Thomas H. Todd for himself his heirs Executors and Administrators doth hereby covenant, promise and agree to and with the said Joseph S. Todd and Isham R. Hooper and the survivor of them the Executor, Administrator and assigns of such survivor that he the said Thomas H. Todd shall and will upon the request of the said Joseph S. Todd and Isham R. Hooper or either of them make do and execute such further and other conveyances and assurances in the same for the better conveying and assuring the aforesaid property on the aforesaid trusts and according to the true intent and meaning of these presents as by their council learned in the Law be legally advised and directed In Witness whereof we the said Thomas H.
