Elias Chapman N. Braswell, of State and District aforesaid
have for the consideration of the sum of two
hundred and fifty two dollars & Ten to him in hand paid by Elias
Chapman of the same place, have granted, bargained, sold and
released and by these presents do grant, bargain, sell and release
unto the said Elias Chapman all that tract of land containing
one hundred and thirty one and a half acres more or less, situate
and lying in the State and District aforesaid on the head branches of
Mountain Creek, waters of Saluda River, beginning on Spanish oak
3x on dead, thence S. 49. E. 17. 50, to stake 3x binding on St. Cooleys
land, thence N. 88. 6. 25. 50, across Aunt Aggie branch to hickory 3x.
on small, thence S. 3. W. 30. across said branch to stake 3x mn, binding
on said Cooley, thence N. 49. W. 7. 50, to stake 3x by a large hickory
on said Cooleys land thence S. 64. W. 32. or to stake on said Cooley
land, thence N. 49. W. 34. 50 to stake 3x on, across public road, binding
on C. Vincent, thence N. 64. E. 30. chs to beginning 3x. being the tract
of land on which said Braswell now lives sold to him by James Cochran
Togeth^r with all and singular the rights, members, hereditaments
and appurtenances to the said place belonging or in any wise incident,
I have and to hold, all and singular the said premises unto the
said Elias Chapman his heirs and assigns forever, And I hereby
bind myself my heirs, Executors and adm^rs. to warrant and defend
all and singular the said premises unto the said Elias Chapman his
heirs, ex^rs. and adm^rs. against all and every person or persons whomsoever
lawfully claiming or to claim the same or any part thereof, In Witness
