Deed for 314 Acres of Land.

Know all men by these presents, that I, John P. Poole, of the State and District aforesaid, for and in consideration of the love and affection I have and bear to my son Thomton P. Poole of the same State and District, have given, granted and conveyed, and by these presents do give, grant and convey unto him the said Thomton P. Poole a certain tract or parcel of land situate lying and being in the State and District aforesaid on the waters of Mush Creek, and bounded as follows: Beginning at a maple corner on a branch, running thence S. 20° degrees W. 48 chains to a red oak 3x. thence South 48° West, 15 Chains to a Rock, thence South 33° East, 31 Chains to a post oak, 3x thence North 68° East 14 Chains 25 Links to a Stake, 3x thence North 10 1/2 East 28 chains to a dead red oak, thence North 41. East, 16 chains 25 links to a post oak 3x thence North 16 East 29 chains 75 links to a chestnut, 3x thence North 6 East 7 Chains to a red oak 3x thence South 86 West, 24 chains to a Stake at Branch, thence down the branch North 1 Chain 60 Links to the mouth of another branch; thence up that other branch West 4 chains to the beginning containing two hundred and fourteen acres, be the same more or less. Do have and to hold the above granted premises unto him the said Thomton P. Poole his heirs and assigns forever. Together with all and singular the rights, members, hereditaments and appurtenances therunto belonging or in anywise incident or appertaining. And I, the said John P. Poole, do hereby bind myself, my heirs, executors, administrators and assigns, forever to warrant and defend the above granted premises unto him the said Thomton P. Poole his heirs and assigns, against myself, my heirs and assigns, and also, against any and every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof. In witness whereof, I have hereunto set my hand and affixed my seal this seventeenth day of November in the year of our Lord one thousand eight hundred and forty.
