 Cox, of Anderson district, and State aforesaid, in consideration of the
 sum of twelve hundred and fifty dollars to me in hand paid by
 George W. Pavenport of the State and dist. aforesaid, have granted, sold
 and released and by these presents do grant, bargain, sell and release
 unto the said Geo. W. Pavenport a plantation and tract of land
 laying in the State and district aforesaid on Mountain Creek waters
 of Saluda River containing two hundred and thirty-three acres be
 the same more or less, beginning in a pine 3x thence running about
 S. 74 N. 31 to a post oak 3x bounded by Jolly Bollings land thence
 S. 10 E. 51 to a stake 3x bounded by Joseph McCulloughs thence N. 16
 W. 22 to a post oak 3x (cut down) bound by Reubin Cox thence with the
 sd Cox line till it intersects with Rebecca Stones land to a hickory,
 3x, thence N. 61 E. to a poplar 3x on the Spring branch thence down
 the sd branch or near the branch to Mountain Creek thence up said
 Creek 40 links from the bank to the old original line thence with the
 original line to the beginning containing two hundred and thirty-
 three acres more or less together with all and singular the rights,
 members, hereditaments and appurtenances to the sd premises belonging,
 or in anywise incident or appertaining to hold and to hold all &
 singular the premises before mentioned unto the sd Geo. W. Pavenport,
 his heirs and assigns forever; and I do hereby bind myself, my heirs,
 executors and administrators to warrant and forever defend all and
 singular the sd premises unto the sd Geo. W. Pavenport his heirs & assigns
 against myself, my heirs and against every other person lawfully
 claiming or to claim the same or any part thereof. Witness my
 hand and seal this seventh day of March in the year of our Lord
 one thousand eight hundred and forty-four & in the sixty-eighth
 year of the Independence of United States of America.
